Lieutenant-Governor

To all to whom these presents shall come, Greeting:

WHEREAS, the Companies Act, R.S.P.E.I., 1974, Cap. C-15 provides that the Lieutenant Governor in Council may, by Letters Patent under the Great Seal, grant a Charter to five or more persons, who shall petition therefor, constituting such persons, and others who may become shareholders in the company thereby created, a body corporate and politic, for any purposes or objects to which the legislative authority of the legislature of Prince Edward Island extends.

have petitioned for a charter under the said Act constituting them a body corporate and politic, for the purposes hereinafter mentioned, by the name of "THE P.E.I. FIDDLERS SOCIETY, INC."

AND WHEREAS, among other things it is in the said petition averred that the amount of the capital stock of the intended company is and shall be without share capital.

C-15, WE DO, by these Our Letters Patent constitute the said petitioners and all others who may become shareholders in the said company, a body corporate and politic, by the name of "THE P.E.I. FIDDLERS SOCIETY, INC."

That the place within the Province of Prince Edward Island which is to be the head office of the said company shall be at Charlottetown, in Queens County.
